The EADS Group continues to work on the grant funding process and right of ways for the sanitary sewer project in the Clear Shade and Verla Drive areas. The repairs have been completed to the manhole at Tuscareka Drive. The township has received payment for the repairs from Penn Lines Co. Clark stated that he received a complaint regarding mud on Dark Shade Drive coming from the entrance to mining site. Clark placed a call to Elk Resources requesting that the mud be cleaned up on Rt. 160. Clark noted that J. Rugg has not returned the recorded maps as of this date. The maps were returned to Rugg on November 21 so that they could be recorded at the Somerset County Recorder of Deeds Office. Rugg is responsible to return to the township two recorded copies of the maps for the townships files. At this time Clark thanked Dave Blough for his many years of elected service to Paint Township. Everyone wished Dave well and a happy retirement. Blough's term ends on December 31, 2017.
