Ordinance No. A Amending Township Ordinance No. 95-107 Adopted June 5, 1995

AN ORDINANCE OF THE TOWNSHIP OF PAINT, SOMERSET COUNTY, PENNSYLVANIA, AMENDING TOWNSHIP ORDINANCE NO. 95-107 TO INCLUDE A STREET AND ITS MAXIMUM SPEED LIMIT, TO REFLECT STREET NAME CHANGES, AND TO REFLECT REVISED MAXIMUM SPEED LIMITS FOR CERTAIN STREETS

WHEREAS, the Township wishes to amend Section 1, paragraph (a), of Article II of Township Ordinance No. 95-107, to include the street known as Havego Road and its maximum speed limit among those streets already specified in said Section 1, paragraph (a), to reflect the street name change of Maple Heights to Sugar Maple Drive due to the recent 9-1-1 addressing in Paint Township, and to reflect revised maximum speed limits for Hayes Street, Statler Road, and Weible Road; and,

WHEREAS, the Township wishes to amend Section 14, paragraph (a), of Article II of Township Ordinance No. 95-107 to reflect the new street name changes of both Maple Heights and Maple Drive to Sugar Maple Drive due to the recent 9-1-1 addressing in Paint Township.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, AND IT IS HEREBY ORDAINED AND ENACTED by the Board of Supervisors of Paint Township, Somerset County, Pennsylvania, as follows:

1. Amendment of Section 1, Paragraph (a), of Article II of Ordinance No. 95-107.

Section 1, paragraph (a), of Article II of Ordinance No. 95-107 of the Township of Paint, which was adopted June 5, 1995, is hereby amended to include Hagevo Road/S.R. 1033, between Route 160 and Morningland Drive, and its maximum speed limit, to reflect the street name change of Maple Heights/T.R. 773 to Sugar Maple Drive/T.R. 773 due to the recent 9-1-1 addressing in Paint Township, and to reflect revised maximum speed limits for Hayes Street/T.R. 802, Statler Road/T.R. 803, and Weible Road/T.R. 705. Therefore, Section 1, paragraph (a), of Article II shall read as follows:

Section 1. Maximum Speed Limits Established on Certain Streets.

(a) Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle, on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

2. Amendment to Section 14, Paragraph (a), of Article II of Ordinance No. 95-107.

Section 14, paragraph (a), of Ordinance No. 95-107 of the Township of Paint, which was adopted June 5, 1995, is hereby amended to reflect the street name changes of both Maple Heights and Maple Drive to Sugar Maple Drive due to the recent 9-1-1 addressing in Paint Township. Therefore, Section 14, paragraph (a), of Article II shall read as follows:

Section 14. Stop Intersections Established.

(a) The following intersections (in addition to intersections with the through highways established by Section 13 of this article, if any) are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or stop street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of The Vehicle Code, and shall not proceed into or across the second-named or intersecting or through street until he has followed all applicable requirements of that section of the law.

AN ORDINANCE REGULATING TRAFFIC AND PARKING IN THE TOWNSHIP OF PAINT, SOMERSET COUNTY, PENNSYLVANIA, AND REPEALING CERTAIN PRIOR ORDINANCES

The Township of Paint ordains as follows:

Article I

General Regulations

Section 1. Definitions and Interpretations.

- (a) Words and phrases, when used in this ordinance, except for sections or articles to which different or additional definitions apply, shall have the meanings ascribed to them in The Vehicle Code (the Act of June 17, 1976, P.L. 162 No. 81), as amended, except that, in this ordinance, the word "street" may be used interchangeably with the word "highway," and shall have the same meaning as the word "highway" as defined in The Vehicle Code.
- (b) The term "legal holidays" as used in this ordinance shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.
- (c) In this ordinance, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

Section 2. Manner of Adopting Permanent Traffic and Parking Regulations.

All traffic and parking regulations of a permanent nature shall be enacted as ordinances or as parts of ordinances or as amendments to ordinances of the Township of Paint, except where the law specifically authorizes less formal action.

Section 3. Temporary and Emergency Regulations.

- (a) The Chief of Police of the Township, or, in his absence or unavailability, the Chairman of the Board of Supervisors, or, in his absence or unavailability, the Vice-Chairman, or, in his absence or unavailability, the Secretary, shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
 - (1) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations; and
 - (2) In the case of emergency public works or public events of limited scope or duration, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.

- (b) These temporary and emergency regulations shall be enforced in the same manner as permanent regulations. Any person who drives or parks a vehicle in violation of any such regulation shall be guilty of a violation and, upon conviction, shall be liable to the penalty set out in the law or elsewhere in this ordinance for a violation of that nature, and, in case of a violation for which no specific penalty is set out in the law or elsewhere in this ordinance, to a fine of \$25 and costs.
- (c) If such temporary or emergency regulations are imposed by the Chief of Police, the ranking Supervisor, in the order listed in Section 3(a), shall be informed as soon as practicable. Such Supervisor may modify or rescind a temporary or emergency regulation imposed by the Chief of Police, and the Board of Supervisors may modify or rescind a temporary or emergency regulation imposed by a single Supervisor.

Section 4. Experimental Regulations.

The Board of Supervisors may, from time to time, designate places upon and along the streets in the Township where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate those locations by proper signs and markings. Those regulations, prohibitions and restrictions shall be effective just as if they had been specified in this ordinance. No person shall drive or park a vehicle in violation of any such regulation, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who violates any provision of this section shall, upon conviction, be liable to the penalty set out in the law or elsewhere in this ordinance for a violation of that nature, and, in case of a violation for which no specific penalty is set out in the law or elsewhere in this ordinance, to a fine of \$25 and costs. **Provided:** The purpose of this section is to allow for test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Township relative to traffic and parking.

Section 5. Traffic on Streets Closed or Restricted for Construction, Maintenance or Special Events.

- (a) The Board of Supervisors or the Roadmaster, as their designee, shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion, while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.
- (b) The Board of Supervisors or the Roadmaster, as their designee, shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is under way and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop, or is signaling that vehicle, by a flag or other device, not to proceed.
- (c) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Section 6. [Reserved for future use.]

Section 7. Authority of Police Officers.

The police officers of the Township shall have authority to direct traffic on the streets in the Township, at intersections in public and in other places where The Vehicle Code or this ordinance applies.

Article II

Traffic Regulations

Section 1. Maximum Speed Limits Established on Certain Streets.

(a) Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle, on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than five (5) miles per hour shall pay an additional fine of \$2 per mile for each mile in excess of five (5) miles per hour over the maximum speed limit.

Sections 2 through 13. [Reserved for future use.]

Section 14. Stop Intersections Established.

(a) The following intersections (in addition to intersections with the through highways established by Section 13 of this article, if any) are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a

vehicle approaching the intersection on the first-named or stop street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of The Vehicle Code, and shall not proceed into or across the second-named or intersecting or through street until he has followed all applicable requirements of that section of the law.

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Article XII

Interpretation and Repeal

Section 1. Severability.

The provisions of this ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the validity of

any of the remaining provisions of this ordinance. It is declared as a legislative intent that this ordinance would have been enacted had that unconstitutional, illegal or otherwise invalid provision not been included in the ordinance.

Section 2. Provisions to be Continuation of Existing Regulations.

The provisions of this ordinance, so far as they are the same as those of ordinances and regulations in force immediately before the enactment of this ordinance, are intended as a continuation of those earlier ordinances and regulations, and not as new enactments. Nothing in this ordinance shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted under any of those repealed or superseded ordinances or regulations.

Section 3. Repeal of Certain Prior Ordinances.

All prior ordinances of the Township of Paint insofar as they deal with the regulation of traffic and/or parking are repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this ordinance. Prior ordinances not inconsistent with or identical to any provision of this ordinance are not repealed. Without limiting the generality of the foregoing, the ordinance of June 4, 1973, providing for weight limits on Township roads is not repealed and remains in full force and effect.

Section 4. Effective Date.

This ordinance shall take effect ten (10) days after adoption.
